## CHAIRPERSON'S MESSAGE

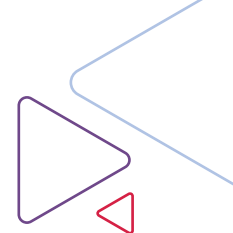
Dear Members,

# Introduction of Tax Stamps on Excisable Drinks:

## A momentous development in Oman Excise Tax

### Introduction

The Oman Tax Authority (OTA), in collaboration with De La Rue (DLR), recently hosted an online workshop aimed at introducing the third phase of the Tax Stamp program to market stakeholders. This workshop marked a significant advancement in Oman's commitment to streamline and enforce excise tax regulations on excisable drinks. In this session, various critical aspects of the program were discussed, providing stakeholders with crucial information to ensure compliance.

### Key Highlights

#### 1. Scope and Coverage

Initially, the Tax Stamp was imposed on cigarettes and other tobacco products. This initiative aimed to combat illicit trade and ensure that all products met the regulatory standards. The scope of this program is now expanding in its third phase to include excisable drinks such as carbonated, sweetened, and energy drinks sold in Mainland Oman. Notably, Duty-Free sales and exports are excluded from this requirement, maintaining focus on products within the local market to tighten control and ensure public health standards.

#### 2. Applicability

The OTA has outlined specific timelines for the implementation of Tax Stamps on excisable drinks to facilitate a smooth transition and compliance:

- Customs Enforcement by 31 January 2025: All excisable products entering the Sultanate of Oman for sale in the local market must have Tax Stamps applied and activated.
- Local Enforcement by 30 April 2025: It will be prohibited to trade any excisable products within the Sultanate that do not carry the Tax Stamps, whether these products are imported or produced locally.

#### 3. Marking Methods

To accommodate the diverse nature of the market and manufacturing processes, two marking methods have been established which will be available to stakeholders:

- Direct to Products (DTP): This method is designed for manufacturing industries, particularly those that are heavily regulated. It



involves printing unique serial numbers directly on individual products using production line systems, supporting various packaging styles including can/bottle carriers.

- Physical Markers: These are applied by manufacturers and importers within secure designated areas. The markers are formatted as small labels (15mm \* 15mm) presented in reels, supporting manual application while preventing reuse due to their frangibility.

#### 4. Key Notes on Digital Tax Stamp (DTS) and Physical Markers

- The DTP framework does not mandate a specific location for the mark, as long as it is readable by a smartphone application, ensuring ease of verification by both authorities and consumers.
- A predetermined fee for the markers is payable directly to DLR through a purchase agreement.
- Importers have the flexibility to appoint third parties to apply Physical Markers in designated areas.
- Use of serialized trackable markers or stamps.
- It is instructed that Tax Stamps be marked on every single unit, even if sold in a package of multiple units.



# Introduction of Tax Stamps on Excisable Drinks:

## A momentous development in Oman Excise Tax

### Importance and Objective behind the requirement of Tax Stamps

The primary goal of introducing tax stamps is to enhance regulatory compliance and streamline tax collection processes. By ensuring that each excisable product is marked, the OTA aims to:

- **Combat Illicit Trade:** Tax stamps make it easier to identify and intercept counterfeit and smuggled goods, protecting legitimate businesses and ensuring consumer safety.
- **Improve Revenue Collection:** Ensure that all products are accurately taxed and contribute to the national revenue, enabling better allocation of public resources and services.
- **Ensure Product Compliance:** Stamped products must meet health and safety standards set by the relevant authorities, promoting public health.
- **Enhance Traceability:** Serialized markers enable relevant authorities to track the journey of each product through the supply chain, facilitating recall processes and quality control.

### Recommendations for Businesses

**1. Product Registration:** It is crucial for taxable persons to identify which of their products fall under the scope of the third phase and ensure these are registered in the Excise system on the OTA portal. This registration process is vital as it facilitates smooth customs clearance during importation, ensuring that businesses comply with the new regulations without facing logistical delays. Businesses must properly classify goods for excise tax purposes to ensure accurate taxation and avoid potential penalties.

**2. Registration with GS1:** Taxable persons should register with GS1, an organization that provides a globally recognized system for product barcodes. This system enhances inventory management, product tracking, and regulatory compliance, thereby improving operational efficiency and reducing the risk of non-compliance.

**3. Automation and Technology:** Business may consider to incorporate excise tax functionalities into ERP systems to streamline tax processes and enhance compliance through advanced tax technology.

**4. Conduct Excise Tax 'Health Checks':** Stakeholders should regularly perform excise tax health checks to identify and address any compliance issues or areas for improvement with the support of external tax advisors. In case of ambiguity, one may seek necessary clarifications from tax authorities to resolve any ambiguities or specific concerns regarding excise tax.

**5. Training:** Businesses and stakeholders must stay informed about the new developments in the excise tax regime. It is recommended that companies conduct comprehensive training sessions for their teams to ensure they are well-equipped to comply with the changes. Understanding the new requirements and procedures will help in seamless integration into their existing operational frameworks.
